The Challenges

Flotek uses JD Edwards EnterpriseOne for Financials and Supply Chain. When implementing JD Edwards five years ago, Flotek had several issues converting inventory data, which was complicated by data integrity issues prior to the conversion. After the conversion, Flotek was carrying a \$500,000 monthly unreconciled variance trying to balance the sub-ledger to the general ledger on inventory valued at \$71 million.
